PROCEEDINGS OF THE STATE LEVEL TECHNICAL COMMITTEE (SLTC)
MEETING HELD ON **30.01.2020**

The State Level Technical Committee (SLTC) meeting was held on 30.01.2020 at 11:00 A.M., in the APCOB Head Office, Vijayawada, to review and finalize the Scales of Finance (SoF) for various crops for the year **2020-21**. The meeting was chaired by Dr. R Shreenath Reddy, Managing Director, APCOB. The representatives from the offices of CC & RCS, SLBC, NABARD, Agriculture University, Departments of Agriculture, Horticulture, Sericulture, Fisheries, Sugars; Senior Officers from SBI, Indian Bank, Syndicate Bank, Saptagiri Grameena Bank and APCOB have taken part in the meeting. The list of participants is enclosed as Annexure.

The General Manager (L&A), APCOB welcomed the Managing Director and all the participants to the meeting. The MD, APCOB explained the steps/procedure involved in fixation of the Scales of Finance and role of SLTC in the process and requested all the members to share their views, make suggestions in moderating the Scales of Finance fixed by the DLTCs (District Level Technical Committees) of the districts.

The scales of finance suggested by the 13 DLTCs for the year 2020-21 were reviewed in detail for each of the irrigated and un-irrigated crops, both Khariff 2019 and Rabi 2019-20 District-wise, fixed by the DLTCs concerned. After having detailed deliberations on the costs involved in raising crops and gross value of yield etc., and the recommendations of the DLTCs, realistic scales of finance were arrived by the SLTC for the year 2020-21 as follows:

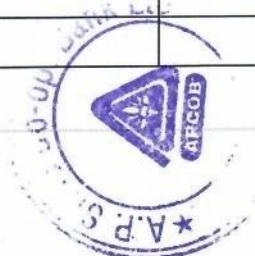

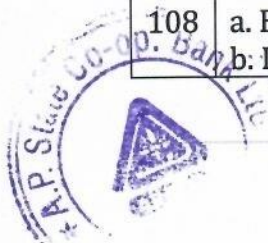

The committee further resolved as under:

1. To obtain the working sheets along with the recommended scales of finance arrived by the DLTCs.
2. To display the Scales of Finance in the notice boards of all the branches.
3. To request the convenors of the DLTCs to adopt the Scales of Finance as fixed by the SLTC and also to place the same before their District Consultative Committees (DCCs) for its adoption/information.
4. To request the DCCBs (DLTCs) to furnish a copy of the details of the Scales of Finance adopted by them to the APCOB.
5. To furnish the list of the crops grown in the state, their duration and categorization of the crops into short duration (crop season less than 12 months) and long duration (other than short duration) crops.
6. To request the DLTCs to inform the reasons where the Scales of finance suggested by them is too high compared to the scales fixed by the SLTC for the year 2020-21 (Srikakulam-Paddy, Krishna-Oilpalm, Prakasam-Capsicum).
7. To discuss with the Fisheries Department and to arrive at the amount of finance to be provided to the fishermen and to communicate to the SLBC for circulation.

The meeting concluded with vote of thanks by the General Manager to all the participants for their active participation and contribution.
