Kindly find the attached proceedings of Special District Level Technical Committee Meeting held on 11.02.2020, wherein the Scale of Finance for Ground Nut Crop is revised as under.

Crop	SLTC proposed for FY 2020-21 Rs.	DLTC Adopted SOF for 2020-21 Rs.
Ground Nut (UI)	20,000-22,000	22000 to 24,000
Ground Nut Irrigated	25000 to 27,000	25,000-27,000

In this regard, we request all the Bankers in the District to follow the DLTC adopted Scale of finance (SOF) for Ground Nut crop for both Irrigated and un-irrigated. The DLTC advised and recommend to display the Scale of Finance in Notice Boards of all Bank Branches in the District.

Please refer to the subject cited above and references mentioned, wherein the District Level Technical Committee for fixing scale of finance for different crops in the district to be finance by bankers during 2019-20 was held on 23.12.2019, the proceedings of our DLTC were sent to State Level Technical Committee, where in the scale of finance in respect of Ground Nut the major crop cultivation in the District for Un Irrigated and Irrigated are fixed as;

Crop	Irrigated	Un irrigated/ Rain fed
Ground Nut	Rs.25000-27000	Rs.24000-26000

The State Level Technical Committee vide ref(2) has communicated the scale of finances for various crops fixed scale of finance for Ground Nut as;

Crop	Irrigated	Un irrigated/ Rain fed (Inter crop Red Gram)
Ground Nut	Rs.25000-27000	Rs.20000-22000

As the scale of finance for G.Nut by SLTC is far below than the DLTC recommendations, an urgent special DLTC is called for on 11.02.2020 in the meeting hall of ADCCB.

During the deliberations it is opinioned by the Joint Director of Agriculture, Anantapur that in Anantapur District G.Nut is sown exclusively without intercrop (red gram). As such the scale of finance proposed by SLTC will not be sufficient.

It is also opinioned by all the Bankers present that, as the scale of finance for previous year viz., 2019-20 is already Rs.22,000-00, a minimum of Rs.24,000-00 be proposed for Anantapur District for enhanced lending's.

In light of above, we request your good offices to move a subject in the ensuing DCC meeting to discuss on the scale of finance and take resolution for requesting SLBC/SLTC for consideration of our revision.
