The district level technical committee (DLTC) meeting was held on 12.01.2021 at collector office meeting hall, Srikakulam .to review and finalize the scales of finances for various crops for the year 2021-22 .The meeting was chaired by Hon'ble Dist.Collector J.NIVAS Garu, DDM NABARD ,Lead district manager, The representatives from the departments of agriculture, animal husbandry, fisheries, Horticulture, Sericulture, Handloom and textiles and major commercial banks. Senior officers from SBI, Indian bank, syndicate bank APGVB, DCCB SRIKAKULAM and Progressive farmers have taken part in the meeting .The list of participants is enclosed as Annexure.

The chief executive officer, DCCB welcomed the Hon'ble Dist. Collector and all the participants to the meeting .The LDM Srikakulam explained the steps /procedure involved in fixation of the scales of finances and role of DLTC in the process and requested all the members to share their views, make suggestions in moderating the scales of Finances fixed by the various departments of the districts.

The scales of finance suggested by the departments for the year 2021-22 were reviewed in details for each of the irrigated and un irrigated crops, both khariff 2021 and rabi 2021-22 crop wise.
