

## **Proceedings of Sub-Committee Meeting**

A meeting of SLBC Sub-committee was held on 01.06.2023 at 3.30PM, in the SLBC conference hall, FGMO office, Vijaywada. The meeting was attended by, Smt. Geeta Rani, Joint Director, PR&RD Govt of AP, OSD (IF & SLBC) Finance Dept, GoAP, Mr. Nirmal Patnayak, DGM, RBI, Mr. Murthy, DGM, NABARD, Executives & Senior officers from major Banks & LDMs. The detailed list of participants is enclosed.

**Sri.Navneet Kumar, General Manager & Convener, SLBC of AP,** extended a warm welcome to the participants and initiated discussion on agenda item.

**Agenda 1: Progress on** Jansurakhsha 3 months campaign at GP Level from 01-04-2023 to 30.06.2023

Assistant General Manager, SLBC of AP, informed that with an objective to enhance the penetration of Jansuraksha Schemes i.e. PMJJBY and PMSBY, DFS is launched a 3-month saturation campaign for Jansuraksha Schemes at Gram Panchayat (GP) level from 01.04.2023 to 30.06.2023. The detailed SOP was given by DFS on 20.03.2023 to District Collectors, All Banks and LDMs.

Lead District Manager to work as the nodal officer at the district level and he has to assign Gram Panchayats with approval of DLCC to the banks for organising the campaign at identified dates. LDM has to continuously monitor the progress of the campaign at the grass root level and upload the information of camps along with allocation to Banks on DFS portal. LDM has to ensure that all Bank/PO branches participate in camp as per the allotment and no Gram Panchayat is left out from holding of camps.

As per DFS SOP, SLBC has to create public awareness in regional languages about the campaign through advertisements in news papers and local media. LDMs has to publicize the campaign by preparing banners and pamphlets at their respective district level.

At State level the expenditure incurred by SLBC for publicity will be shared to member banks

**Shri.Nirmal Patnayak,DGM,RBI** in his remarks informed that all banks should actively participate in the Jansuraksha 3 months campaign and also conduct FLC camps to improve financial literacy and encourage digital transactions at village level.

**Smt.Geeta Rani, Joint Director, PR&RD** informed that directions from state government forwarded to all the District Collectors and CEOs in the state to conduct Jansuraksha campaign at GP level and madam requested SLBC to send the district wise progress to their department for follow up with CEOs.

Shri Navneet Kumar, General Manager and Convener SLBC in his remarks informed that since last 3 years SLBC,AP was done well in all schemes, which was appreciated by DFS and State government in many forums and the same spirt should be continued by the banks in conducting Jansuraksha camps at GP level.
