Reg: SLBC Sub-Committee meeting on 10.06.2021 – Business Continuity Plan (Banks) & COVID Advisory & Other issues

Department of Health, Medical and Family welfare, Govt of AP, vide GO no 294 dated 10.06.2021, informed that, after a thorough review of the Covid-19 prevalence and in partial modification of the orders issued in the GO 272 Dated 31.05.2021 , Government has extended the curfew upto 20.06.2021 with modified timings from 2.00 PM to 6.00 AM with effect from 11.06.2021, to contain the spread of Covid-19 in the State.

In view of the above, a Sub Committee meeting of SLBC through VC mode has been conducted today (10.06.2021). Sri Sharath Chandra, AGM from RBI, DGM from NABARD , executives and officials from various Banks have participated in the virtual meeting.

The forum has arrived following resolutions in the meeting to implement.

- **Business hours of the banks revised for all branches from 10.00 AM to 2.00 PM and working hours upto 4.00 PM, effective from 11.06.2021 (Synchronising the AP State Curfew directions) or till further instructions.**
- **All Administrative offices shall work from 10.00 AM to 5.00 PM.**
- Keeping in view of the health risk to customers and Bank staff, forum fervently appeal the customers to make use the services of alternative delivery channels like ATM/Mobile banking/Internet Banking/ UPI based platforms/Bank Mitra Services and, visit the branch as a last resort.
- Banks shall also motivate their customers to utilise digital platforms like mobile/internet banking/UPI based transactions to meet their day to day banking needs.
- Banks shall take all necessary steps to keep alternative delivery channels active uninterruptedly.



- Controllers of all the Banks are requested to issue suitable instructions to branches and offices and also advise Bank branches to display the revised business hours on notice board as well as at prominent places in their premises.
- All Covid-19 guidelines issued by the District administration/State administration from time to time to be followed strictly.
- Any instructions /advisory issued by local District Administration will supersede the SLBC advisory.

Other Issues Discussed and Agreed in the Meeting.

Jagananna thodu:

- All Banks shall submit the quarterly interest subvention claim of Jagananna thodu scheme immediately to Govt in prescribed template for release of eligible claim amount. Banks also agreed to put a mechanism in place for regular submission of data and getting the reimbursement automatically.

YSR Bima Scheme:

- In view of discontinuation of YSR Bima Scheme by the Govt through Banks, all Banks shall reconcile the premium amount received from Government and remit the left over premium to Government along with enrolled beneficiary details immediately. (format shared by SLBC vide e mail date 12.02.2021).

PMAY-AHP (U) Scheme :

- As Government of AP decided to pay and clear the liability of all loans of 300 sq ft category flats, all Banks to submit the borrowers details of such loans in prescribed format (shared by SLBC through e mail dated 09.06.2021) to Government marking a copy to SLBC.

Submission of data to SLBC :

- All member Banks are advised to sensitize the staff responsible for preparation and submission of different data to SLBC , to ensure **accurate and timely submission**. This will enable the SLBC to conduct the meetings as per the yearly calendar.
