Proceedings of Sub-Committee Meeting

A meeting of SLBC Sub-committee was held on 14.06.2023 at 11.00AM, in the SLBC conference hall, FGMO office, Vijaywada. The meeting was attended by, Sri R.K. Mahana, General Manager, RBI, Sri. Navneet Kumar, General Manager & Convener, SLBC, AP, Executives & Senior officers from major Banks. The detailed list of participants is enclosed.

Sri. Navneet Kumar, General Manager & Convener, SLBC of AP, extended a warm welcome to General Manager, RBI and the participants and initiated discussion on agenda item.

Agenda 1: Management of Data Flow at LBS Fora

Assistant General Manager, SLBC of AP, informed that as per para 2.3.4 of Master Circular of RBI dated April 3, 2023 on Lead Bank Scheme vide which member banks are required to submit the data to SLBC within 15 days of the next quarter. However, it is observed by SLBC that some of the member banks are invariably submitting the data late thereby deviating from said instructions. It is needless to mention that this delays the preparation of agenda and holding of steering committee meeting in time. It is further noticed that data submitted by some banks are inconsistent posing a challenge to have a meaningful discussion in various meetings e.g. EC-MSME, SLBC etc. This has been observed during last one year. All the member banks are advised to submit the correct data and adhere stipulated time norms.

Sri Navneet Kumar, General Manager and Convener SLBC in his remarks informed that since all banks are done well in achievement of targets since last 3 years and same was reflected in SLBC, performance. He advised all the banks to submit accurate data to SLBC and a senior level officer to check the data before submitting to SLBC and there should not be any discrepancy in data which is fed in the SLBC portal. The data submission timelines should be followed invariably by all banks.

Sri R.K. Mahana, General Manager, RBI informed that data (i.e. no. of branches of a particular bank) is not matching as per actuals in districts viz.. Annamayya, Chittoor, Kakinada, Parvathipuram Manyam and Vizianagaram. In Annamayya district SBI reported 40 branches instead of 39, likewise in Chittoor, BOB reported 3 branches instead of 2,UBI reported 29 instead of 30,SBI reported 32 branches instead of 31,HDFC reported 9 branches instead of 7,ICICI reported 7 branches instead of 5,Indusind bank reported 9 branches instead of 3. In Parvathipuram Manyam, UBI reported 18 branches instead of 17, ICICI reported 4 branches instead of 3, APGCB reported 20 branches instead of 27. In Vizianagaram district, Canara Bank reported 15 branches instead of 14, PNB reported 8 branches instead of 7, UBI reported 39 branches instead of 4,Bandhan Bank reported 61 branches instead of 57, Axis Bank reported 5 branches instead of 4,ICICI reported 5 branches instead of 4,Indusind reported 2 branches instead of 1,KVB reported 6 branches instead of 7,APCOB reported 16 branches instead of 15,APGVB reported 76 branches instead of 69, Equitas SFB reported 0 branches instead of 1 and Fincare SFB reported 0 branches instead of 1 and Fincare SFB reported 0 branches instead of 1

There is discrepancy in outstanding advances and disbursements of BOB, BOI, BOM, APGVB and CUB of Vizianagaram district. In Nandyal district Canara Bank delayed submission of data by one week.

He advised all the banks to rectify the number of bank branches reported and actuals in mentioned districts and also present error free data in various forums viz. DCC and SLBC.

He also advised SLBC to inform all LDMs to share DCC/DLRC meeting agenda at least 3 days prior to the meeting. He expressed concern about banks submitting data late in SLBC portal as well as inconsistent data. This led to delay in conducting SLBC, EC-MSME meeting as well as portrayal of wrong picture about the progress made. He advised SLBC to mark action points to those banks seeking rectification within a time frame. (Action – Respective banks)

Sri Krishna, AGM, SBI informed that data as per SLBC format is shared by their central office and the same was uploaded in SLBC portal. If any discrepancy observed by SLBC, it should be brought to the notice of state controller and get it rectified. In response to this SLBC coordinator Sri. Raju Babu informed that, a senior level officer/executive from the state, to cross check the data before submission to SLBC and ownership of the data lies with Banks only. (Action- All member banks)

Sri Krupaji, Senior Manager, Axis Bank and Lakshmikanth Kunda, Chief Manager, ICICI bank informed that, there should be uniform MSME format should be formulated for all the states for submission of data in portal. AGM ,SLBC intervened and informed that, since the data is being generated and shared to all the banks by IT/MIS of its head office, a common format will be convenient for submission of data throughout India instead of generating different formats for different states. In response to this RBI, GM informed that FIDD, RBI, APRO will study the format of Tamilnadu state and compare with AP. Afterwards a recommendation can be made for bringing uniformity in MSME format, if need be. (Action – RBI, FIDD, AP, SLBC, AP)

The forum resolved the following action points for Flaw less data flow in LBS fora

All Banks submit error free data within stipulated time norms and the data should be cross checked by senior level officer/executive before uploading in SLBC portal.

All Banks rectify the error in number of branches reported and actuals in districts viz. Annamayya, Chittoor, Kakinada, Parvathipuram Manyam and Vizianagaram.

RBI to take up with its Central Office, the need of a common format for all the states for ease of data submission and accuracy.

The meeting ended with vote of Thanks.
