Pursuant to orders on extension of nation lockdown till May 3,2020, in a bid to contain the spread of COVID -19, a Sub-Committee meeting with major member Banks of SLBC held on **15.04.2020** at SLBC office , Vijayawada.

Action points emerged in the meeting are hereunder:

1. All Bank Branches in the state to adopt following time lines.

Business Hours: 10.00 am to 2.00 pm

Working Hours: Normal i.e 10.00 am to 5.00 pm.

The above time lines to be implemented with immediate effect.

2. LDMs to take lead to get the **RED ZONES/HOT SPOTS** notification from District authorities and to circulate the same all member Banks on daily basis.
3. Areas which are declared as **RED ZONES/HOT SPOTS** by respective District Administration, concerned Bank's Controller to take decision on closure/Function of branches in those locations according to the instructions of District Administration.
4. Banks have to Keep Banking correspondent (BCs) and ATM outlets in active status to enable beneficiaries to withdraw the DBT amount without any hassle.
5. Banks should ensure the availability of sanitizers at Branch, BC locations and ATM locations.
6. Banks should take all possible measures to ensure maintaining of Physical Distance of customers in the branch premises.
7. Banks should ensure availability of sufficient cash at Branches/ATMs to meet the demand.

8. Banks can seek District Administration/Police Department co-operation with co coordination of respective LDMs, for deployment of adequate security personnel at Bank branches and BCs to maintain physical distancing, law and order and staggering of account holders, where the situation warrants.
9. Members requested to obtain Govt of AP approval for exemption of stamp duty on loan documents in wake of restrictions in lockdown period.
10. **The above decisions are applicable until further instructions or expiry of lock down period i.e May 3, 2020, whichever is earlier.**
11. **These proceedings will supercede the decisions of SLBC earlier meetings made in wake of COVID-19**
12. **The instructions of District Administration in the event of any emergency will supercede the above SLBC decisions.**
