Proceedings of Sub-Committee meeting with Major member Banks of SLBC held on 29.05.2020 at SLBC Conference Hall on Business Continuity Measures from 1st of June 2020.

In Continuation of our earlier instructions issued on Business Continuity Measures, SLBC of Andhra Pradesh conducted a meeting on 29.05.2020 with Major Banks at SLBC Conference Hall and resolved that, all Bank Branches in the state to restore normal Business timings i.e

Business Hours: 10.00 am to 4.00 pm
Working Hours: 10.00 am to 5.00 pm

The remaining major issues are here under.

1. Banks to ensure availability of sufficient cash at Branches/ATMs to meet the demand.
2. Banks to ensure the availability of sanitizers at Branch, BC locations and ATM locations. And also ensure to take all precautionary measures to maintain Physical Distance of customers in the branch premises.
3. Banks can seek District Administration/Police Department co-operation with co coordination of respective LDMs, for deployment of adequate security personnel at Bank branches and BC point to maintain physical distancing, law and order and staggering of account holders, where the situation warrants.
4. Digital Payment transaction may be encouraged as far as possible.
5. LDMs to take lead to get the **latest notifications on COVID-19** (if any) from District Administrations and circulate the same to all member Banks as per the instructions of District Administration.
6. **These proceedings will supersede the decisions of SLBC earlier meetings made in wake of COVID-19.**
