Proceedings of Sub-Committee Meeting

A meeting of SLBC Sub-committee was held on 07.11.2022 through virtual mode. The meeting was chaired by Smt Dr (Smt) Poonam Malakondaiah IAS Spl Chief Secretary, Agriculture, Govt of AP. The other participants of the VC meeting are Shri R Amarendra Kumar Director, Director AH, AGM from RBI, RO, Hyderabad, SLBC Coordinator Shri Navneet Kumar, Officials from Animal Husbandry department, LDM's from all 26 Districts of Andhra Pradesh and Executives & Senior officers from Major Banks.

Asst General Manager, **SLBC of AP** extended a warm welcome to the participants and presented the agenda items to the house for discussion (through VC) from APIIC Mangalgiri.

The Special Chief Secretary, Govt of AP, in her opening remarks emphasized the importance of PKCC- (Pasu Kisan Credit Card) scheme and the advantages to the farmers. Further she advised the bankers to accord priority to sanction KCC loans for YSR Cheyutha/Asara beneficiaries, as they are existing account holders of the banks and already purchased the milch cattle. Furthermore, department also hand holding these people in respect of animal feed and veterinary aid. As such department has identified around 2.66 laks beneficiaries to cover under the scheme, of them already forty thousand members received the bank finance. Hence, she requested bankers support to the rest.

Director, Animal Husbańdry department, informed that, the department is planning to cover of all new entrants for the year 2022-23 under YSR Cheyutha programmes targeting one (1) Lakh animals/Units per year and to ensure the coverage of all the beneficiaries of Cheyutha/Aasara Schemes (2,66,447) who have already purchased livestock under PKCC. Further he explained the modalities to be followed in this regard.

Coordinator SLBC explained that the theme of Sub Committee Meeting as Agriculture and main agenda of this meeting is PKCC- Pasu Kisan Credit Card achievements as per set target of 2.66 lakhs during the revised time period from 15/09/2022 to 15/03/2023.

Asst General Manager, **SLBC of AP** informed that Ministry of Finance, Department of Financial Services, Gol has launched a campaign for issue of KCC to the eligible beneficiaries for Animal Husbandry & Fishery activities from Nov 08, 2021, where camps are being conducted on every Friday of the week. As per the DFS communication the campaign has been extended till 31st March 2023. Hence, requested the bankers to take active role in the said camps, paying due focus on applications received from YSR Cheyutha/Asara beneficiaries.

After the deliberations, the following action points emanated.

Weekly district level camps are to be conducted as per the Nationwide AHDF KCC Campaign till 15th March 2023 for providing Pasu Kisan Credit cards (PKCC) facility to all eligible Animal Husbandry farmers involved in Animal Husbandry activities and the beneficiaries of Cheyutha/Aasara Schemes who have already purchased livestock.

(Action: Banks)

The applications received and mobilised during the camps will be directly submitted to the branches along with necessary documents as per check list by local Veterinary Assistant Surgeons, where to Bank Managers shall obtain and acknowledge the receipt.

(Action: Banks & AH Dept)

The branches shall process the applications as per the timeline of 15 days credit decision to be informed to the concerned LDM through respective bank district coordinator.

(Action: Banks)

❖ Banks shall follow the approved SOP to process and sanction the loans under the scheme.

(Action : Banks)

The applications of YSR Cheyutha/Asara beneficiaries to be routed only to the branches through which they are receiving other benefits.

(Action: AH Dept)

LDMs shall update the KCC application data into DFS portal regularly, along with data of RRBs including in their sponsored Bank's data.

(Action: LDMs)

Agenda: 2.Grant Assistance from MANARD under FIF-Installation of Roof top solar units /UPS at branches of DCCB.

Asst General Manager, **SLBC of AP**, informed that, APCOB submitted a proposal requesting to recommend for installation of Roof top solar units /UPS at branches of DCCB to receive Grant Assistance from NABARD under FIF for their 20 branches in Eluru district.

They have sought grant assistance for the following.

Director, Animal Husbandry informed that The Department of Animal Husbandry & Dairying, Government of India is implementing the scheme of National Livestock Mission. The revised scheme of National Livestock Mission (NLM) aims towards employment generation, entrepreneurship development, increase in per animal productivity and thus targeting increased production of meat, goat milk, egg and wool under the umbrella scheme Development Programme.

It is subsidy linked central scheme, where the subsidy amount will be channelized through the Small Industries Development Bank of India (SIDBI).

Under the scheme applications will be sourced and sponsored through the department staff in an dedicated on line portal, where requested the bankers to accord credit decision without prolonged delay.

There are 236 pending application in Entrepreneurship Development Programme (EDP) Portal as on date where banks has to take speedy credit decision.

The meeting was concluded with the vote of thanks to the Chair and other dignitaries.
